

MINUTES OF THE FRAMPTON PARISH COUNCIL MEETING HELD ON 21st July 2022 AT 19.30hrs AT Frampton Village Hall.

Tina Clare member of the public attended to see if would like to join council. Mr Pryke attended as a member of the public to raise his concerns regarding the speed of vehicles travelling to Frampton RSPB and the lack of passing places. Also concerned traffic to RSPB Frampton will increase once new visitor centre opens.

43. Cllr D McNally – Fly Tipping in Frampton (agenda item 4 21.07.22)

Data on fly tipping sent to clerk today (21/07/22) and will be forwarded to Councillors.

Cllr McNally commented there had been staff issues due to covid and these issues are still arising. Cllr McNally also commented there is no evidence that the increase in fly tipping is due to the Tip being closed for two days.

Cllr Burton commented that he lived in Frampton and had noticed fly tipping more often on a Friday morning after the Tip had been closed Wednesday and Thursday. This is predominantly black bag waste. Councillor Burton always reported to fly swat team who are fantastic. Cllr Burton also commented that he once took a TV that had been fly tipped and staff at Tip said as it was fly tipped should not have been accepted. Cllr McNally was unsure about this and would need to find out the policy. Clerk to send data to all Councillors.
