103. Apologies (agenda item 1 17.03.22)

Apologies were received from Cllr Watson (Boston Borough Council) and Cllr Austin (Lincolnshire County Council)

104. Declarations of interest (agenda item 2 17.03.22)

105. Approval of the minutes for meeting held 17th February 2022 (agenda item 3 17.03.22)

The Council Resolved to adopt the minutes of 17/02/2022 as a true record.

106. Planning Applications (agenda item 4 17.03.22)

a) B/21/0413, Re-plan and re-design of the housing layout within phases 2 & 3 (154 dwellings) on parts of the site previously approved under B/18/0039 (for the erection of up to 195 dwellings); including provision of 13 additional units (to create a combined total of 208 dwellings) and revisions to proposed house types at Land at Middlegate Road West, Frampton.

Frampton Parish Council have no objections. Chairman and Clerk to send a letter to planning.

b) B/22/0073, Proposed extension to existing single garage to a triple size garage with floor space above at The Moores, Church End, Frampton, Boston, PE20 1AD

Frampton Parish Council have no objections to this application, although would like reassurance that there is no plan for this to be an addition dwelling.

107. Environment of the Parish Including Cllr A Austin LCC (agenda item 5 17.03.22)

Cllr Deane commented that the Alison Homes Development had no proper entrance to the site just a tarmac slope. Cyclist therefore would need to come out onto the road. Clerk to email the developers.

Cllr Hildred commented that the telegraph poles on Fen Road were defying gravity. Clerk to contact Western Power.

Cllr Burton commented that within days of potholes not being repaired on Clatterdykes, after stated as being completed. Markings had been sprayed on the road, although had not been to check they had been completed.

Cllr Balgarnie commented that the Frampton RSPB sign was in need of being replaced. Cllr Balgarnie will report on FixMyStreet, if no joy Clerk will write to Highways.

Cllr Royce commented that the Man Hole cover was broken and therefore Man Hole not covered on West End Road opposite Bannisters Field. This is a danger to the public and road users Clerk will report to Highways as a matter of urgency.

Cllr Hladun comment that the sign on junction of Lily's Bridge is very scruffy.

108. Dog Foul Bins (agenda item 6 17.03.22)

One resident of Frampton asked if Frampton Parish Council would consider putting in extra Dog Foul Bins within the Parish. Frampton Parish Council unanimously votes no to install extra Dog Foul Bins due to cost implications and felt that Frampton had sufficient Dog Foul Bins.

Cllr Cooper will be stepping down as Parish Councillor from May 2022. Frampton Parish Council would thank Cllr Cooper for his many years of being a part of Frampton Parish Council. Therefore, from May 2022 Frampton Parish Council will have a vacancy for an additional Parish Councillor.

NALC have issued the pay scales for Clerks. Frampton Parish Council Clerk salary will increase from £12.98 to £13.21 back dated from April 2021. The pay increase was unanimously agreed by all councillors
