

MINUTES OF THE FRAMPTON PARISH COUNCIL MEETING HELD ON 16TH SEPTEMBER 2021 AT 20.00hrs AT HUBBERT'S BRIDGE COMMUNITY CENTRE

Cllr Hildred commented there is lack of footpath linking A52 and Claymond Court.

Cllr Hildred also comment that it would be nice for Frampton Parish Council to install some play equipment. Clerk will look into funding for this.

Cllr Cooper comment that the bridal way sign on London Road where meets Ralphs Lane is actually 40M in the wrong place. Cllr Cooper also commented that the pot hole on Sandholme Lane are very bad especially on the bend. Clerk to report on fix my street.

Cllr Royce commented that the hedge by Park Farm has been cut back. Cllr Royce also commented that hedge at the top of Church Green Lane belonging to the Smith's Trust still needs cutting back. Clerk to send letter to Smith's Trust.
