### 42. Environment of the Parish Including Cllr A Austin LCC (agenda item 4 15.07.21)

Cllr Welton commented that he had met today (15/07/21) with planning. Cllr Welton will send a report through to the Clerk in the next week or two.

Cllr Austin commented she had been given permission to speak at the Environment and Economy LCC meeting. Cllr Austin commented operations of Household Waste Recycling Centres, recommendation was to scrap the booking system. It was concluded the booking system would be scrapped from 1<sup>st</sup> September 2021. Cllr Austin also commented that it had taken a year but the Give Way sign at the top of Bannisters Lane had been replaced.

Cllr Hildred commented his concerned regarding rubbish from Cherry Tree Lodge on the road and also noted letter he had received from a parishioner regarding a neighbour's fence. Cllr Ashton replied that the clerk had, had contact from Environment Agency and were visiting the property yesterday (14/07/21), with regards to the fencing matter it was felt this was matter for Boston Borough Council. Cllr Hladun commented that the rubbish that had been dumped on the bank had been cleared. Cllr Hladun also commented that Network Rail had still not replaced the gates. Clerk asked to investigate.

Cllr Deane commented parishioners concerned the Bus Station would be moved. Cllr Welton confirmed the Bus Station or Bus Stops are not planned to be moved, if the Bus Station does move the Bus Stops will stay at the same locations. Cllr Deane asked if the Bus Stops would still have shelters, Cllr Welton was not able to answer this question as not a decision for Boston Borough Council to make.

Cllr Cooper commented that Framfest is still set to be going ahead on the 14<sup>th</sup> August 2021. Cllr Cooper also commented that EON had been servicing the Street Lights, some lights could not be seen due to hedge and Tree growth. EON had cut this back to allowanced and cleared cuttings.

Cllr Watson commented that the scrapping of the Household Waste and Recycling Centres was long overdue and a positive move.

Cllr Ashton (Chairman) commented the response from the Planning Department was the Shepherds Hut was not in breach of regulations, as a Parish there is nothing we can do. Cllr Ashton also commented that the War Memorial had now been tended to but we need to find a long term solution for the maintenance. Cllr Ashton commented the hedge opposite park is not too bad but will need a good trim in the future. Cllr Ashton is very happy will road names for the new development and also noted how nice the Church yard is looking at the moment. Cllr Ashton commented that planning permission had been refused for extra access at Thorney Lane due to Tree Protection Order reasons.
